14:00 16. Workshop on new tools for data input into AMIS statistical database

The Secretariat has upgraded the AMIS Commodity Balance Sheet tool on the basis of the comments and feedback received from the focal points during the past year. The main effort was to make the tool more flexible to accommodate country-specific data management practices and to enable storage, visualization and updating of monthly forecasts for each commodity and member country.

The objective of the session is to present these developments, to familiarize the focal points with the tools and the new software features and to gather suggestions for further improving and refining the tools.
